Nomination Packet

President-Elect- Nomination Packet Should Include

- 1. Letter of Intent from the Candidate stating why he/she is interested in serving as IPA President-Elect
- 2. Curriculum Vitae (CV)
- 3. Nomination Letters from 3 different IPA member societies in good standing. Out of 3 letters, one letter must be from the National Pediatric Society of which he/she is a member.
- 4. Duly-filled Conflict of Interest (COI) Form
- 5. Duly Signed Code of Conduct

* The post of President-Elect of the IPA requires a rotation of geographic representation. The Eligible Presidential candidates must represent a region from which there has been no President-Elect for the two preceding terms. Therefore, for the years 2025-2027, IPA cannot accept nominations for candidates from Asia Pacific or Middle-East and North Africa regions

- To be eligible for nomination, a Member Society must have paid membership dues at least for the last two years (2023 and 2024) prior to the Council of Delegates meeting.
- Preferably someone who has served in IPA or its member societies in a high-level position.

Standing Committee- Nomination Packet Should Include

- 1. Letter of Intent from the Candidate stating why he/she is interested in serving as IPA SC
- 2. Curriculum Vitae (CV)
- 3. A letter of nomination from the respective IPA National member society where he/she is a member.
- 4. A letter of support from the regional society (validation of documents only)
- 5. Duly-filled Conflict of Interest (COI) Form
- 6. Duly Signed Code of Conduct

NOTE

- The Nomination files for the IPA SC from IPA National member societies, whether they are members of the corresponding IPA regional society or not, <u>shall forward the application of their proposed candidate to the regional society with a copy mark to the Admin office (adminoffice@ipa-world.org) and the President Office (naveenthacker.office@gmail.com) The regional society will prepare a final slate of candidates from the region and will send the nomination latest by 09th November 2024 at 11.59 PM Jakarta Time/ 4.59 PM UTC (Coordinated Universal Time)/ 5.59 PM GMT/BST (Greenwich Mean Time/ British Summer Time) to the IPA Executive Director at Admin Office with a copy mark to President Office. No direct nomination will be accepted.

- Respective regional societies will send nominations from their region. Subspeciality societies will send the nominations directly to the IPA Executive Director at the IPA Admin Office, with a copy marked to the IPA President Office.
- To be eligible for nomination, a Member Society must have paid membership dues at least for the last two years (2023 and 2024) before the Council of Delegates meeting.

IPA Executive Officers- Nomination Packet should Include

- 1. Letter of Intent from the Candidate stating why he/she is interested in serving as IPA **Executive Officer**
- 2. Curriculum Vitae (CV)
- 3. A letter from the respective IPA member society where he/she is a member states that he/she is in good standing with their pediatric society.
- 4. Duly-filled Conflict of Interest (COI) Form
- 5. Duly Signed Code of Conduct

- The Nomination Files for IPA President-Elect, Executive Officers, and IPA Congress 2029 Bid should be directly sent to the IPA Executive Director at the IPA Admin Office (adminoffice@ipa-world.org) with a copy mark to IPA President Office (naveenthacker.office@gmail.com) latest by 09th November 2024 at 11.59 PM Jakarta Time/ 4.59 PM UTC (Coordinated Universal Time)/ 5.59 PM GMT/BST (Greenwich Mean Time/ British Summer Time)
- The eligible candidates for IPA President-Elect, Standing Committee, Executive Officers, and IPA Congress 2029 Bid must be present at the IPA Council of Delegate meeting during the election process. Only in exceptional situations/extraordinary situations the Independent Election Committee (IEC) after a thorough review will take the final decision and inform the concerned authority about the absence of the candidate.
- To be eligible for bidding, a Member Society must have paid membership dues at least for the last two years (2023 and 2024) before the Council of Delegates meeting
